

Contest Rules

1. Eligibility

Free Beef Jerky For A Year ! (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of J-Ray's Jerky and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

2. Sponsor

5. How to Enter

Online: This method of entry will be available by visiting our website (www.jraysjerky.com) and Each time you order on line you will be entered in the drawing. If you order 10 times, you will be entered ten times. The more your entered the better your odds of winning.

Enter as many times as you wish through the duration of the Contest Period, regardless of method of entry. All entries become the property of Sponsor and will not be acknowledged or returned.

6. Prize Drawing

On or about January 02, 2020, the Sponsor will select a potential winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about January 02, 2020. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email, mail or phone. The potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize.
